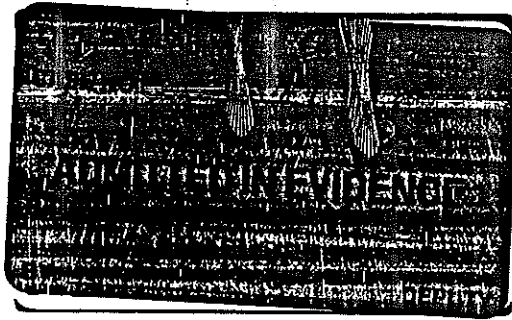


Beloved Mother:

Enclosed is a check for \$2,320.00 to be applied for one quarter for Kathleen Hammond and one quarter for Lisa de Longchamps. In the event that either one of them does not attend, this is to be applied towards future quarter(s) for myself. I am looking forward to attending a second quarter when it is available.

I need to know if it is proper to do exorcisms on new people in the teachings following closely your procedures. I have ten people, since I have returned, who have become interested in the teachings because of my individual contact with them, who have asked to be exorcised. I am willing to do this in the name of the Christ. Seven people I have already exorcised -- three of whom were exorcised at the focus. Gene Bernstein and others walked in during the exorcism and went into an adjoining room, where he criticized me to others in the home. The criticism was that I had no business exorcising people using your format. That night, one member of the focus came to me and told me of this and that he and some others felt that what I had done was wrong. I did not expect opposition from within the focus, or I never would have attempted to do it there. Five more people were scheduled to be exorcised a week later, but I have cancelled them indefinitely until I hear from you. Because of the opposition, I have lost energy, but have regained it after the third day. My back went out, all of my muscles have ached, and I have made three visits to the chiropractor since this experience. I feel that the backlash I have had from the last exorcism was not from the people I exorcised, but because of the criticism which occurred during and after the exorcism. I told Rory that I was going to give an exorcism that night and was going to follow your format, and he had no objection. He also had no criticism afterwards for what I did. I can see more clearly why he walks alone with God. I would never have questioned this, but because of the criticism, I have agreed to check this out with you. I really was not aware I should protect myself from the people in the focus and, also, that I should be willing to walk alone. In the future I will know. I am willing to serve and to even die for my fellow man in the name of the Christ, but need counsel from you.

The focus here is running with more compassion and flow. We are all learning by being together. I thank you for your service and dedication and all you have done for me.
