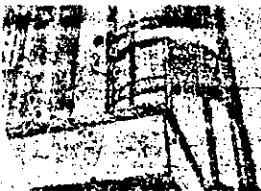

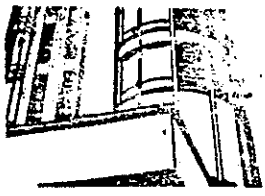
Beloved Mother,

She will stay w/ her cousins and Aunt & Uncle who live in Pasadena, or another Aunt & Uncle in Upland California. She and I have lived alone for the last year and three months. She will return to her mother for three months while I am at S.U. She does not get along with her mother because of the mothers inadequacy in several areas. She really does not want to go there and not wanting to accompany me to Honolulu International she has no choice but to return to her mothers home. She will return to live with me upon my return from school.

I feel it is my duty as a father to remain in close contact with her as she needs guidance with the tender age she is in. 70% of her class last year smoked pot and many started sexual activities - she needs

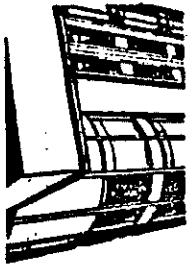
me as a reminder that I care for her and
