you to know that those were damaged
in mail and not - your check for
refund of those prints is on the way and
if you keep acting like that as far
as I am concerned your name can be
taken off the mailing list because I
feel it is very immature and you
didn't even give us a chance to tell
us what was wrong before you bowled
us out - so good luck with your
whole life, bye bye. Unquote.

Dear Randall,

The enclosed message was placed by you on my dictaphone August 13, 1975. One of the prints arrived with bubbles on it. After a couple days in my sun room another print bubbled up also. Heat seems to be causing this. I thought these colored prints were beautiful and wanted to frame them but to have framed them and then have them do this would make the situation worse. When I returned them to S. I. I in no way was reflecting on the Summit organization as an attack or on the Acorn Masters. It was that I wanted the best to come out of the Summit. Who ever put them together did a great job visually but they are not durable and should be treated for heat - like in the sun, or a very warm room.

Now concerning your attitude toward it was with extreme hostility - your public relations is very low. You have hurt me before and now deeply. About my first day of school you turned out...

the Summit Office meeting shouting
"I hope your whole organization falls
apart" for anyone to hear who was
walking by that Office, many students
were made by. You are about the
poorest example I know of harmony
and an expression of the Holy Spirit.
You may be able to get by with this
with the staff being Mother's husband
but my higher self I will not tolerate
such behavior. I am not that masochist
that I would let you make me a slave
under your domination & control. Your
original outburst of hostility caused great
heart ache and burden for me during my
quarter - I kept it to myself and forgave
you as I can do now.

The Ascended Master teachings are so
good & high and I am hooked, but, not
on your personal running of the organization
with your behavior. Unless we resolve
this between you and me I will not be
attending the University again nor will I

I wonder if the issue of hostility was not really viciousness concerning money having to refund for those pictures. I do not know your past story with business or dealing with money except Sam Hatten could hardly contain himself from killing you because of an issue over money while he said was really true and silly to blow up over. You have fallen short of Ascended Master behavior as I read their works. What empire are you building, is your attitude for yourself or God. Again say I will not be made to feel unworthy by you, or controlled by you by fear that you will drop me from your lists as you threaten to do. I can practice A.M. teachings without your organization but I sincerely prefer to be a part of it. I will not live in fear that if I construct

dollars of loss by having the focus
on my property.

I will question what I give in the future
